On January 10, the Virginia General Assembly convened in Richmond to begin its 2024 legislative session. Following the November elections, in which all 40 seats in the House of Delegates and the Senate were up for grabs, pro-abortion legislators have once again regained control of the General Assembly. With this victory, the General Assembly has a promising opportunity to enact proactive legislation and to protect sexual and reproductive health, rights, and freedom in the state.

Virginia Reproductive Equity Alliance's (VREA) Repro Advocacy Day

On January 22, the Latina Institute Virginia Team traveled to Richmond to participate in the VREA's Repro Advocacy Day alongside abortion and reproductive justice advocates, supporters, and allies. In the morning, 52 advocates split up and met with 24 legislative offices to discuss the VREA's policy agenda. Recognizing that reproductive justice encompasses more than just abortion care; the Latina Institute Virginia has been proud to stand behind a number of proactive policies that champion a range of sexual and reproductive healthcare issues--

Later that day, advocates sat in on the Senate Commerce and Labor Committee to show support for Senator Ghazala Hashmi's Contraceptive Equity Act (SB238) – a bill that would ensure more people across the state, including Latinas/xs and other communities of color, can access and afford the care they need. After testimony from several members of the VREA, including over very own Field Organizer, Alyssa Aldape, the bill ultimately passed out of committee (8 Yeas; 6 Nays). Since then, the bill has gone on to pass out of the Senate Finance Committee and will soon make its way to the Senate floor for a full vote – stay tuned!

CONNECTING WITH LEGISLATORS

The following day, the State Manager, Khenia Haro-Perez and Policy Advocate, Gabriella Watson, met with legislators to discuss how the Latina Institute Virginia is committed to building power in Latino/x communities and will continue to fight for reproductive freedom and bodily autonomy throughout Virginia.

BIRTH IN COLOR (BIC) ADVOCACY DAY

Finally on January 24, the team stayed in Richmond to join Birth in Color for their annual Advocacy Day. This year, BIC has engaged in various legislative measures, including the establishment of a stillbirth support fund, the inclusion of doula care in insurance coverage, and the implementation of unconscious bias training for healthcare professionals. 
